# CO-PRESIDENT'S REPORT

## Moving Forward and Continuing the Fight to Making Democracy Work

What a busy June for LWVEA!

We had both our Annual Meeting and our Annual Retreat, on June 10 and 17, respectively. Both meetings yielded excellent recommendations and action items going forward into the new League year 2017-2018 and beyond. Some of these recommendations are already being acted upon while others are being consolidated for further review and follow up/action by appropriate teams. We have several new energetic and talented members on our board while a couple of valuable long-time board members left due to moving and other reasons. Thankfully they agreed to stay on as off-board advisors.

As we move forward with our new board, we asked Suzanne Barba, one of our longtime former board



members for words of wisdom. She reminded us that critical issues can change daily. The League needs to meet the changes and challenges to

keep LWVEA strong. However, recruitment and retention of members should be an everyday effort of the League. Suzanne advised, "I think the basic strategy is the same as it always has been – personal contact in recruiting and giving new members a task, which is important, a task that they can be accomplished using their skill sets."

In addition, we also asked Suzanne to recommend changes to the League's role in the community to better engage the community and make the greatest impact.

She suggested that active participation in community events was a good way to increase our exposure and is both doable and fun. By actively participating in community events, the League can find out the issues the residents are interested in; it also helps the League spread the word about the role that the League is playing in advocating public engagement and public policy. She reminded us that utilizing technology fully is another way to reach out to the community and engage people so as to make the greatest impact.

"The League has been around for almost 100 years and from that time to the present, it has an excellent reputation based on upholding its basic mission—*To be a nonpartisan political organization that encourages the informed and active participation of the public in government and influences public policy through education and advocacy.* That is an amazing mission and the reason the League has an enviable reputation. keeping that past accomplishments in mind when there are little bumps in the present road to accomplishing the league's audacious mission."

10. League Updates: each representative shared the work of her local League, and Rita was able to get contact information from Veda concerning the study her league is doing regarding charter schools vs. traditional public schools. # Report from Conference

I return home fully energized, enthused, and ready to take action!

Five board members attended the League of Women Voters California conference held in May in Sacramento. Here are their thoughts on the events they attended:

**April Anderson:** As a new member to the LWV, attending the convention accelerated my understanding of the LWV and the policies, procedures, and operations involved in membership, outreach, advocacy, action, and education. In addition to these logistical and practical matters, what struck me more than anything was the deep community of devoted activists--individuals who have committed the majority of their lives in many cases to the League in order to better their own communities and to promote democracy. In our current political climate, to see people from all walks of life join together and move toward a shared goal inspired great hope in me for the future. Not only did the communal-aspect encourage me to become more involved in my own League, but it also reminded me of how powerful an impact a group can have to effect real change.

On a more issues-oriented note, I used my time at the convention to learn from other Leagues: to take their enterprising works and funnel them into ideas for what the LWVEA can do. In particular, I attended a caucus on Climate Change, which was especially poignant in terms of timing, since it was held the day after the current administration pulled out from the Paris climate accord. The group of League members present at this caucus shared practical, innovative, and conscientious solutions for combating climate change through sustainability at the local level. Again, I was moved, and so I joined the team on Climate Change in the LVWC to learn more and become more involved in advocacy work.

A truly heartfelt thank you to the LWVEA for allowing me to attend this convention. I am full of thanksgiving and gratitude for the opportunity to learn and to grow more inspired and impassioned about the work of the League.

**Richard Maurer:** As a new board member of the League of Women Voters, Eden Area, I attended this year's California Convention of the League, held in Sacramento in early June. I found the experience rewarding and hopeful for our Democracy; so many informed and engaged members attuned to the important public policy issues of the day. This active group of league members is contributing to our country, for 'Democracy is not a spectator sport,' it is inspiring to see League members serving as good examples of citizenship; alert to public issues, open to hearing all sides of an issue, aware of the positions of our elected officials, and prepared to speak out and take a position in the interests of positive programs responsive to the real needs of all our fellow citizens and state and nation.

In addition to attending the main plenary sessions and representing my league by voting on matters brought before the convention attendees, I also attended workshops and caucus meetings covering specific issues. Presentations on Response to Climate Change, Fixing Proposition 13, and Single-Payer Health Care for Californians were most informative, and allowed participants to explore these important issues in depth with the well prepared speakers. These significant issues are likely to come before the general public and our elected officials in the near future for debate and action. It was a welcome opportunity to become better informed about the pros and cons of past and coming personal and legislative action on these issues.

I am proud to be a league member and grow as a better informed American citizen. I look forward to making my contribution to better inform my fellow citizens and provide them with accurate and timely information to help them better judge and act on political and public policy issues in the future.

**Rita Duncan:** As Co-Chair of the Program Committee my experience at the League of Women Voters State Convention in Sacramento was invaluable. The experience provided me with a deeper understanding of the League's mission, organizational structure and the commitment of the members to make democracy work. It also provided me with the opportunity to network and meet members from Northern, Southern, Central California and the National Leagues. The following experiences are what resonated the most with me during the Convention:

## Recognition:

Recognizing members who were celebrating their 50 years of volunteer service to the League of Women Voters was inspiring. It was motivational to learn about the various Leagues and their projects that received recognition for their engagement in their communities, creating visibility for their leagues and strengthening Democracy. Both of these events illustrated the long-

term and level of commitment of the League's members. It made me proud to be a part of the organization and validated my decision to join the League and serve on the Eden Area Board

### Workshops

**The Risk & Resiliency: Planning for Uncertain Future** workshop which I attended equipped the participants with tools and a process to assist Leagues in broadening their perspective about issues they decide to advocate for and underscored how our Political, Environmental, Social, Technology, Economic and Legal/Regulatory sectors (PESTEL) are connected. The tools and process provided a method to prioritize issues weighing time, energy, resources and the impact the various sectors may have on the issue. The training materials are on the League's website.

### Caucuses

I also attended the **Bridging the Divided Caucus** which highlighted work accomplished by Leagues.

**Sips and Civility "Understanding Immigration"**

**Education Forum** was presented by the San Diego League. The topic was Refugees, Immigration Myths, and DACA which was a big success; there were 121 people in attendance at the forum. Offering free beer at the event attracted a lot of young people.

**Gender Representation on City Commissions** report was conducted by the Pasadena Area League. The report results underscored the need for gender equality on commissions which are appointed positions. The report showed the need for attention to be focused on gender inequality on many of the cities commissions and the need for representation of women for gender balance. In the future this may be a great issue for the Eden Area League to research for our area.

### Guest Speakers

**Mayor Michael Tubbs – City of Stockton**, first African-American mayor of Stockton and the youngest mayor elected in American history. In his speech he stressed the need for compassion when interacting with individuals who are unable to have a civil discourse. He cited the example of an incident when Black Lives Matters disrupted one of the City's meetings. Mayor Tubbs shared he learned during the incident that one of the mothers protesting had a son who was shot and killed by a police officer seven years ago and she was still holding on to the pain and anger from her son's death. He reminded the audience that often when individuals are angry, hostile, disrupted and acting uncivil they are operating from unresolved pain and feelings they are not being heard. This insight was a great reminder for me personally to listen and be more cognitive of individuals who are in my opinion acting uncivil during a public discourse.

**Brooke Binkowski - Editor and writer for**

**Snopes.com.** Brook emphasized the need for individuals to take a break from listening to news on smartphones, TV, radios and social media platforms. Many of us listen to news when we are driving, wake-up in the morning and before we go to sleep. Sometime we check on our smart phones during the day to find out the latest news story. Ms. Binkowski believes this behavior contributes to a part of the stress society is experiencing. She also spoke of the importance of us doing our own fact checking in light of the alternative facts being circulated. We need to do our own research on issues that are important to us and not rely on the news media.

In closing I want to reiterate what a great educational experience the State Convention provided for me to learn about the League of Women Voters and the inspiration I gained to hopefully help the Eden Area Chapter obtain our goals. Thanks again for the opportunity and sponsorship.

***Senate Health Care Bill is not Worthy of this Great Nation - Legislation Will Defund Medicaid and Harm Millions of Americans***

Washington, DC – The League of Women Voters president, **Chris Carson** today issued the following statement on the "Better Care Reconciliation Act of 2017" unveiled by Senate leadership:

"The Better Care Reconciliation Act is even worse than the version we saw pass in the House of Representatives and is not worthy of this great nation. The cuts to Medicaid will be massive and will destroy the system that so many Americans rely on. This is a nasty bill that will hurt millions of Americans and we urge Senators to reject it.

"It is not at all surprising that this bill is a terrible one. Legislation developed in secret and rushed to passage is usually trying to hide something. Like the House bill, the Senate plan will cut coverage and raise costs for millions of Americans while giving a huge tax break to the wealthiest individuals and large corporations. The Senators who wrote this bill should be ashamed of themselves.

"As the League has said before, we know the Affordable Care Act is not perfect, however it has successfully provided health care coverage to tens of millions of Americans who previously went without.

"The Senate health care bill will hurt tens of millions of people across our nation. Rushing through this legislation that will negatively impact so many Americans is just wrong."
